## 1. Information We Collect

When you create an account or interact with MockTalk, we collect and store the following types of personal data:

### User Information

- Full name
- Email address
- Profile image
- Password (securely hashed)
- Two-factor authentication status
- Email verification status
- Timestamps of account creation and updates
- Login failure counts and lockout-related timestamps
- Session security version

### Login Activity

- IP address
- Browser user-agent

- Login success/failure logs with timestamps

## Service Usage

- Text-based interview transcripts
- Resume enhancement content generated by AI

## 2. How We Use Your Information

Your data is collected and processed solely for the following purposes:

- Providing and maintaining access to MockTalk services
- Generating personalized interview simulations and feedback
- Enabling resume enhancements and feedback features
- Tracking login activity for account security
- Responding to legitimate user-initiated support requests
- Ensuring the integrity and security of our platform

We do **not** use your personal data to train any AI models.

We do **not** sell or share personal data with any third parties for marketing or analytics.

We **only** share enhanced resumes if you choose to export or share them.

## 3. Data Storage & Security

Your data is securely stored using industry-standard encryption and access protocols on **Neon (USA)** cloud-hosted infrastructure. We implement reasonable technical, physical, and organizational measures to protect your personal information against unauthorized access, alteration, disclosure, or destruction.

## 4. User Rights

As a user of MockTalk, you have the following rights:

- **Access & Portability** – You may request a copy of the personal data we hold about you.
- **Correction** – You may update inaccurate or incomplete information.
- **Deletion** – You may request full account and data deletion at any time.

- **Resend** – Transactional email delivery

These providers only process data on our behalf and do not access it for any other purpose.

We do **not** share your data with advertisers, data brokers, or any unrelated third parties.

The only information you may export or share at your discretion is your **AI-enhanced resume**.
